- \$42.00 per hour - two children late request
- \$40.00 per hour - Non-Contracted time
- \$80.00 per hour - After House Non-Contracted time (after 5:30 p.m.)
- Prorated by 15 minute increments

A discount applied up to two times a year for one week of vacation.

# Tuition Agreement

---

**Tuition:** Tuition is billed on a monthly basis. School closings have been taken into account as an average and days of attendance cannot be exchanged for days when the school is closed. You are responsible for checking the school calendar to see how this affects your individual child's schedule.

Tuition for additional services such as, hired additional support, county and state contracts, and other non-typical programming is subject to vary on an individual basis.

**Withdrawal Policy:** St. David's Center requires a one-month notice be given in writing to withdraw from the ECE Program. Official forms can be requested by contacting the Assistant Director at 952-548-8771. A full month's notice must be given prior to the first of the month, otherwise full tuition for the current month the notice occurred in, and the following month will be charged. For example, if a notice is given on December 15, tuition will be owed for the remainder of December as well as January. To withdraw at the end of December and not be charged for January, notice must be given by November 30. Full monthly tuition is required for any withdrawal.

**Enrollment Deposit:** For all new families, in order to guarantee your child's enrollment, we require a deposit of half your monthly tuition for each child attending.

- If you are starting in the summer, this deposit is due May 1<sup>st</sup>
- If you are starting in the School Year, the deposit is due August 1<sup>st</sup>.
- Please Note: We cannot refund your enrollment deposit if you decide not to attend our program after those dates.
- Once attending ECE, your enrollment deposit will go towards your first month of tuition in ECE.

**Payment:** St. David's center requires an automatic payment withdrawal. Tuition will be charged monthly on the date you specify when completing the Automatic Payment Request Form, along with any other ECE related charges.

**Schedule Change Fee:** \$50.00 will be assessed for **each change in admissions scheduling after April 1, 2022.**

**Drop-In Extended Day:** Drop-In Extended Day is available when space permits on your child's regular attendance days as a convenience for families on an occasional basis. This rate cannot be substituted for regularly contracted extended day. Drop-in fees are prorated every 15 minutes and are billed monthly on your tuition statement. Forms are located on the counter outside office 123. **Non-Contracted Time:** St. David's Center charges a fee of \$10.00 every 15 minutes a child is left before or beyond their contracted program time.

**After Hours Charges:** St. David's Center ECE does not operate after 5:30 p.m. Therefore, parents will be billed \$20.00 for any child picked up between 5:31 and 5:45 p.m. and \$40.00 for any child picked up between 5:45 p.m. and 6:00 p.m. Charges will continue to accrue at a rate of \$40.00 per every half hour until the child has been picked up.

**Suspension/Dismissal:** St. David's Center reserves the right to suspend or demit a child from the program for non-payment of tuition by the child's family. Please refer to the Admission and Demission Policy contained in the Parent Handbook. Parents whose tuition is not current will not be allowed to enroll their children in the next session (e.g., Summer 2022).

**Vacation Credits:** Vacation Credits are given to families using the 6 Hour or full-day options only and do not apply to children who are enrolled in the 3-Hour Option. Eligible families may receive up to two weeks of

vacation credit for two full weeks of absence. The credit rates are listed on the 2022-2023 Tuition Rates sheet. Vacation Credit forms are located on the counter outside of ECE Leadership Office 123.

**Sick Leave:** There is no credit given for days that your child misses due to illness. Special financial arrangements may be made, however, when there is a chronic, prolonged illness and/or family hardship. This may be discussed with the Early Childhood Education Director.

**Second Child Discount:** There is a 10% discount off of the regular tuition rate for a second and/or third child enrolled simultaneously. The discount will be given on the lowest rate if your children are enrolled in programs with different costs.

**Scholarships** –St. David’s Center has Financial Resources both within our organization and outside our organization that might be helpful to your family. A limited number of partial scholarships are available for families in need of financial assistance. Scholarship consideration requires that families fill out a Financial Assistance Application, which is reviewed by the Finance Department.
